Using the Planning Portal

The Planning Portal is a website managed by TerraQuest on behalf of the Department for Infrastructure and 10 local councils. Users of the Planning Portal site are bound by the terms and conditions set out below so please read these carefully before continuing.

You should also refer to our <u>Privacy Policy</u> and <u>Cookie Policy</u> when using this document.

Please be aware that other websites, which are accessible from the Planning Portal, may contain terms and conditions which are different from those provided by the Planning Portal.

Permitted Use

You are authorised to view and download the materials on the Planning Portal. You may print off individual pages of the content from the Planning Portal for private or personal use, provided that any proprietary notices, marks, logos or other legends that appear on the copied screens remain, and are not removed from the printed or stored images of such screens.
